SUBJECT: Recruitment of Positions Previously Classified Using Delegation of Position Classification Authority (DCA) Overrides

1. Reference: Memorandum, EAGA-CP-CC, subject: Discontinuance of DCA Overrides to Upgrade KN Positions.
2. The referenced memorandum prevents misclassification of Korean National (KN) positions by commanders and managers who exercise their Delegation of Position Classification Authority (DCA).
3. Effective immediately, when any U.S. or KN position, which has previously been upgraded due to the use of a DCA override, becomes vacant, it will be reclassified to the correct level prior to recruitment. This applies to all positions, including positions that were approved by the Eighth United States Army Commanding General and Chief of Staff.
