

MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: Labor Management Agreement between the United States Forces Korea and the Korean Employees Union

1. The Labor Management Agreement (LMA) between the United States Forces Korea (USFK) and the USFK Korean Employees Union (KEU), was renegotiated and signed on 27 September 2011. This LMA will remain in effect through 26 September 2013 or until it is revised. This LMA will be posted on the 8<sup>th</sup> Army Portal under DHRM.
2. The agreement provides a framework for labor relations between the USFK and KEU at all levels of command. This agreement sets forth specific rights as well as obligations that affect the Employer, Union, and employees. Commanders and supervisors are requested to ensure full compliance with this agreement.
3. Requests for interpretation and clarification of the agreement or reports of non-compliance should be directed to the Civilian Personnel Director, Headquarters, United States Forces Korea, ATTN: FKCP-LPM, Unit #15237, APO AP 96205-5237.
