SUBJET: ROK Election Day Holiday

1. Reference USFK Regulation 690-1, Civilian Personnel Regulations and Procedures – Korean Nationals, paragraph 6-4g, 4 October 1994.
2. The Republic of Korea Government has designated 15 April 2004, General Election Day, as a temporary public holiday. In accordance with the referenced regulation, recommend the following be used in your official notification to commanders about this temporary holiday.

“The Republic of Korea Government has designated 15 April 2004, General Election Day, a temporary Korean Holiday. In accordance with paragraph 6-4g, USFK Regulation 690-1, Korean employees of USFK will be released without charge to leave or loss of pay for the number of duty hours for which they are normally scheduled. Korean employees deemed essential and required to work will be paid holiday premium pay for all hours worked. Alternate days off for employees required to work are not authorized. Questions about the holiday should be directed to your servicing Civilian Personnel Office or Civilian Personnel Advisory Center.”
