CAMP POLICIES, PROCEDURES AND CAMPER RELEASE. WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT.

In consideration for my pet being admitted to Yongsan Pet Care Center Boarding, I make the following representations and agree to all of the following policies, procedures, terms and conditions:

- 1. BOARDING REQUIREMENTS:** My pet meets the following boarding requirements. He/she is current on all vaccines, is in good health, and free of fleas, ticks and parasites with a copy of current veterinarian records. Belongings are all labeled with first and last name. I have completed the Yongsan Pet Care Center Boarding Application and have provided Yongsan Pet Care Center valid credit card number and information.
- 2. FOOD:** I understand I provide food for my animal(s) and my animal(s) will be fed twice a day basically. I agree to pay for the extra fee for food in case I don't bring food for my animal(s).
- 3. PHOTO/VIDEO RELEASE:** I allow Yongsan Pet Care Center, Yongsan FMWR, and/or AFN to use my dog's name, images and video taken while at the facility in any form, format, for use, at any time, in any media, marketing, advertising, illustration, and trade or promotion materials. I agree that this provision shall be bound on me and all my successors, heirs, legal representatives and assigns.
- 4. PERSONAL PROPERTY:** I agree that Yongsan Pet Care Center shall not be responsible or liable for any lost, stolen or damaged personal property belonging to either me or my dog. I also understand and agree that my pet's collar may be removed in the boarding area to prevent injury to any pets. If my pet causes any damage to Yongsan Pet Care Center Facility or Equipment, I agree to be fully responsible for the full cost of any repair or replacement, depending on what is needed.
- 5. BOARDING FEES:** I agree to pay for all Boarding Fees, Deposit, Services and products with the credit card number I have provided in the Boarding Application or by cash or check at the time I pick up my pet. I give my full permission for Yongsan Pet Care Center to charge any of the credit card numbers I provided on the Boarding Application for any unpaid fees, services or products. I further agree to pay the cost of any check or debit charges returned or challenges for to any reason.
- 6. LATE FEES & CHARGES:** I understand that I will be charged a full boarding day fee if I do not pick up my pet by 17:45 on the listed "pick up" date on the Boarding Application.
- 7. AGGRESSIVE PETS:** My pet is not aggressive. I understand that aggressive pets are not permitted to board at Yongsan Pet Care Center. I also understand if my pet acts or exhibits unacceptable behavior, he/she may be asked not to return to the Yongsan Pet Care Center. Such determinations shall be made at the sole discretion of Yongsan Pet Care Center.



8. **ABANDONED PETS:** Yongsan Pet Care Center is a place where all dogs and cats can be boarded. No Pet may be abandoned at Yongsan Pet Care Center. I agree that I will not neglect to pick up my pet from Yongsan Pet Care Center by the time he/she is scheduled to be picked up without providing notification prior to my delay. Any pet left at Yongsan Pet Care Center without any contact, instructions or notification failure. I understand that if I abandon my pet at Yongsan Pet Care Center, that Yongsan Pet Care Center will, by default, become the legal owner and guardian of the pet. Yongsan Pet Care Center will, in their sole discretion, determine whether to try to re-home and adopt the pet from Yongsan Pet Care Center or will relinquish the camper to an unrelated shelter of their choice. **I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY PET AT YONGSAN PET CARE CENTER, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY PET AND WILL HAVE NO RECOURSE AGAINST YONGSAN PET CARE CENTER AS PROVIDED BELOW.**
9. **DUTY OF DISCLOSE:** I have disclosed any and all medical or other conditions, included but not limited to personality concerns or behaviors that may affect, limit or prevent my pet's ability to board at the Yongsan Pet Care Center.
10. **ACCEPTANCE AND ACKNOWLEDGEMENT OF CAMP PARTICIPATION RISK:** I fully understand that (a) there are inherent and potential risks involved with interactions between humans and animals, as well as between animals and other animals, which may result in property damage or bodily injury, including permanent disability, sickness or death to human or animal and (b) there may be other risks not known to the owner or staff nor readily foreseeable at this time (Collectively "Risks") I fully accept and assume all risks and responsibility for all risks, including, without limitation, all loses, costs and damages incurred as a result of me or my pet's participation in boarding.
11. **VETERINARIAN LIABILITY AND CARE:** I allow Yongsan Pet Care Center to obtain medical treatment for my pet, if, in sole discretion it appears that he/she is ill, injury or exhibits any other behavior that would reasonably suggest that my dog may need medical attention. **I AGREE THAT I AM FULLY RESPONSIBLE FOR THE COST OF ANY SUCH MEDICAL TREATMENT AND FOR THE COST OF TRANSPORTATION FOR THE PURPOSE OF SUCH TREATMENT, PROVIDED TO MY PET.**

Waiver, release and indemnification. I hereby expressly and forever generally waive, discharge claims, indemnify, release from liability, save, hold harmless and defend and covenant not to use Yongsan Pet Care Center, advertisers, owners, employees, volunteers and any parties owning from and against any and all injury, liability, claims, litigation, actions, suits, cost, losses, damages, expenses or demands (including reasonable attorney's fees) of every character whatsoever on account of, arising out of, resulting from or relating in any way to (a) any act or omission of the release, including negligence, and (b) my or my pet's participation in activities at Yongsan Pet Care Center, or otherwise. I further agree to indemnify, save and hold harmless the release from any claims, litigation, actions, suits, cost, losses, damages, expenses, attorney's fees, injuries or demands as the result of any such claim I agree that this release shall be binding on me, my successors, heirs, legal representatives and assigns. I also expressly and forever release Yongsan Pet Care Center from any duty to protect me or my pet(s) from the injury of any kind, and agree that even if Yongsan Pet Care Center choose to implement safety precautions, such actions shall not alter the fact that I have released Yongsan Pet Care Center from any duty to protect me or my pet(s).

I have read and fully understand the terms of these boarding policies, procedures and camp release, waiver of liability, assumption of risk an indemnity agreement and understand that I have given up substantial rights by signing it and have signed it freely and voluntarily without any inducement, assurance or guarantee and intend it to be a complete and unconditional release of all liability to the greatest extent permitted by law and agree that if any portion of this agreement is held to be invalid or unenforceable, that the remainder of the agreement shall remain in full force and effective. I agree that it is



intended that all terms of this agreement control despite any particular statute or law that would otherwise protect me or my dog(s).

I, the undersigned, hereby acknowledge and agree all the information provided in this boarding application is complete and accurate to the best of my knowledge. I further acknowledge and agree that I have read and agree to all the terms and conditions in the Yongsan Pet Care Center Boarding Policies, Procedures, Release, Waiver of Liability, Assumption of Risk and Indemnification Agreement, as they may be amended from time to time, which are included and fully incorporated into this application.
