TO PROTECT OTHERS

OUT IN TOWN, YOU MAY ENCOUNTER:

- TEMPERATURE CHECKS AT ENTRANCES TO BUILDINGS
- MANDATORY MASK WEAR IN CERTAIN LOCATIONS
- STAGGERED SEATING ARRANGEMENTS

FOR YOUR PROTECTION, USFK RECOMMENDS THAT YOU:

- AVOID CROWDED PUBLIC TRANSIT; LEAVE EMPTY SEATS WHERE POSSIBLE
- USE ELECTRONIC PAYMENT (CREDIT/DEBIT); AVOID CASH
- MINIMIZE GROUP ACTIVITIES AND SOCIAL GATHERINGS
- USE TAKEOUT/DELIVERY WHENEVER POSSIBLE; MINIMIZE TIME IF DINING IN; STAGGER SEATS TO AVOID FACE-TO-FACE CONTACT

TO PROTECT YOURSELF

- STRICT HYGIENE AND WORKPLACE SANITIZATION
- ACTIVE LIFESTYLE AND HEALTHY DIET
- REST AND SLEEP
- WORK / LIFE BALANCE

TO PROTECT YOUR BUBBLE

- RECOMMEND 2M (6FT), MINIMUM 1M (3FT) SOCIAL DISTANCE
- MASK: WORN WHEN SEPARATION CANNOT BE MAINTAINED
- AVOID LARGE GROUPS AND CROWDS
- NO HANDSHAKES



TO PROTECT OTHERS

- STAY HOME WHEN SICK
- MAXIMIZE TELEWORK, FLEXIBLE SCHEDULES, AND SICK LEAVE
- CALL THE USFK COVID HOTLINE IF YOU FEEL SYMPTOMS: 050-3337-2556

ON INSTALLATION: ALL ACTIVITIES ARE AUTHORIZED

OFF INSTALLATION: ALL TRAVEL WITHIN KOREA (INCLUDING JEJU) AND ALL ACTIVITIES ARE AUTHORIZED EXCEPT THOSE LISTED BELOW
